in May, Syman LLC was contracted by facility owner to perform quarterly routine facility inspections quarterly visual assessment reports at the Nisula Gravel Pit Facility, the SWPPP and prior quarterly inspection documentation was missing. in July 2019 DEQ made an unannounced site visit and noted the missing on site SWPPP and documentation. SWPPP was updated to reflect past changes and was then placed on site and subsequent inspection report are located in the SWPPP binder. No dewatering has occurred from the site since July 2019. SWPPP documentation has been kept current with EPA standards and all deq's areas of concern with Nisula Pit have been identified and resolved.

A sample was taken 7/16/19 to Analytical Lab in Boise ID for assessment. test results were in compliance with EPA. No other samples were taken, discharge from pit has been suspended.
