By the exit of the intake and the entrance of the truck scale, there is water that pools up in that area.

The quarterly storm water sample visual assessments were cloudy and had a brown color to them. There was no odor to the sample. Samples were sent in and analyzed for mercury as required by permit. The results were as follows. 1/17/2019 outfall 1 is 0.00477mg/L, outfall 2 is 0.00894mg/L, on 10/4/2019 outfall 1 is 0.0489ug/L, outfall 2 is 0.588ug/L
