Re: Request for Permit Application under the NPDES Program for Storm Water Discharges to the Puyallup River and other Waters
Subject to Federal and Tribal Jurisdiction

Dear Mr. Thompson:

During our April 21, 2009, meeting between the City of Tacoma (City), the U.S. Environmental Protection Agency (EPA), and the Puyallup Tribe, we discussed the outfalls owned and operated by the City that discharge municipal storm water runoff to waters of the United States subject to Federal and Tribal jurisdiction. Specifically, the City identified the Cleveland Way Pump Station and the T-Street Gulch Basin Outfall as examples of such outfalls.

At the meeting, we confirmed the need for EPA-issued permit(s) authorizing such discharges under the National Pollutant Discharge Elimination System (NPDES) permit program.

Upon review of the City's storm sewer system maps and a map of Puyallup Tribal Settlement Agreement Lands and Tribal Trust Lands, we find that the following outfalls also discharge to waters subject to Tribal and Federal jurisdiction, and require authorization to discharge under an EPA-issued NPDES permit(s):

Therefore, pursuant to the NPDES permit application requirements for "large" and "medium" municipal separate storm sewer discharges at 40 CFR §122.26(d), we request that the City submit a permit application for all of the above referenced outfalls no later than 180 days from the receipt date of this letter.

Because the permit application requirements for large and medium municipal separate storm sewer discharges require a two-part application that was to be submitted in the past, we have enclosed a streamlined permit application package. These modified application requirements consolidate and summarize the information required by regulations at 40 CFR 122.26(d)(1) and (2). With the concurrence of the Puyallup Tribe, we have exercised our discretion to adapt these permit application requirements to the City's existing and ongoing storm water management program.

Please send the application package to my attention at the address above no later than 180 days from the receipt of this letter. We request that a copy of the complete application package also be sent directly to the Puyallup Tribe of Indians at the following address:
